- Loss at 3.9%, lowest ever recorded; lower usage due to more rain early in month
- Well #3 pumping 140 gal/min, well #1 still not pumping (may try to run soon)
- Question raised as to payment for eline by HGWSC; Aleta to research minutes & report.
- Leak fixed on S Gabriel Drive (Rogeman's front yard); small leak still in Humphrey's front yard.
- Anticipating input from Billy at AWW Tech regarding retrofitting well #2: Denny emphasized importance.
- For planning purposes, valves will need replacement due to leaks (Ing's yard bad ~\$2K, Berry's yard ok, main ~\$5K); control panel in pumphouse still needs rework/automation.
- New tap on 122 Skyview Terrace, required two road crossings to accommodate taps for 120 and 124 Skyview Terrace. Cost increased from allowance of \$6,500 approved last month to \$8,000.
- Ben made motion to modify original amount of \$6,500 to increase by \$1,500 for installing new tap, Denny 2nd, passed 4-0-0
