<u>Call to Order</u>: A quorum present, the Chairperson called meeting to order at 8:10 P.M.

Darla objected to the inclusion of discussion between herself and the chair in regard to an unknown address on a Resale Certificate Request during May. Danny made motion to approve minutes with corrections, striking discussion between Chair and Darla as not having been made in meeting. Darla 2nd, **Motion carried 2-1-0**

POA Officers Reports

(In order prescribed in Bylaws):

Chairperson's Report: Virginia: * Friendly Concern #1 Concrete planters acquired by the POA for lot 19 were delivered but not placed as designed, neighbor was informed. * Concern #2, property owner concerned of new fencing placement in regard to property line and water meter. No ACC approval being requested by neighbor. Virginia visited site and determined at least a survey should be made. Contacted owner to stop construction until a new survey was provided. Complied.

*A Quit Claim Deed to HGEPOA for the property know as Arroyo, was received, filed and recorded with Williamson County Official Public Records on June 21, 2023 by the Chair.

*Reported that WSC was in planning stages with Leander for Emergency Water Use via a tap. Well #1 is offline due to lack of water to sustain pumping. Flushing did create concerns of a well or tower leaks, neighbors keeping watch of water usage.

Vice Chairman's Report: Darla

Secretary's Report: Virginia – *ACC process; meet in smaller room, same night same place, with notice via the POA Agenda, but only when an improvement request is ready for approval and signatures. Owner and membership can attend when desired. *Bank visit to investigate check scanning process, online check payments, etc. to eliminate the double account being used having become convoluted when BBVA became PNC and account was still under WSC. WSC still has an account and the POA account is 'hidden' under that account. Issue, Property Owners and Resale Checks are still deposited to the PNC account as well as online PayHOA Property Owner payments, however, the hand written checks have another name and account number. Needs further discussion. *Delinquencies: Total greater than \$9,000. Originally billed \$15,829, collected \$6,206, delinquent \$9,623. Possibility property owners not familiar with new billing process.

<u>**Treasurer's Report</u>**: Helen (treasurer's reports are not approved or published on website). Reported deposits for June of \$712. A May deposit of \$803 was reported not having been available due to absence. Question: PayHOA ACH charges vary- determined to be equaling the number of checks in batch process.</u>

<u>Resale Certificates:</u> Darla – June was reported early in June.

PayHOA Committee: Veronica & Virginia, Veronica familiarizing herself with the system, Virginia continues to find new reporting and features, making that effort much easier. PayHOA has been paid \$1195 to date.
